Terms and Conditions

1. Your £30 deposit is non-refundable.
2. By paying your deposit you confirm that you are committed to raising a further £150 or more in sponsorship. Gift Aid does not count towards your target.
3. Your place is non-transferrable by you.
4. You must notify us immediately if you can no longer take part so we can seek to reallocate the place to another participant.
5. If you fail to take part and/or do not meet your fundraising target, we reserve the right to invoice you the cost to the Charity of your entry at £150 in addition to forfeiture of your £30 non-refundable deposit.
6. Any monies raised through fundraising platforms (e.g. Just Giving, Enthuse, Facebook) are non-refundable by the Charity.
7. You are responsible for the health and safety of yourself and others during the event.
8. Failure to respond to communications from the Charity regarding your entry and/or lack of evidence that you are attempting to reach your fundraising target may result in forfeiture of your entry.
9. You must adhere to the event organisers health and safety guidelines.

Taking part

You participate in this event at your own risk. Cheltenham Animal Shelter will not be held responsible for any injury or illness resulting from your participation in the event. If you are granted a Cheltenham Animal Shelter charity place, you agree that you will undertake suitable training provided by the trainer from the organisation Blaze given on the day of the challenge.

In the event of being unable to participate due to injury or any other issue, you must let Cheltenham Animal Shelter know as soon as possible so that your place may be cancelled.

Cheltenham Animal Shelter reserves the right to revoke places in exceptional circumstances.

The event date, format and capacity may be subject to change by the event organiser due to government guidance, social distance restrictions or for any other reason.

The event may be cancelled due to government guidance; Cheltenham Animal Shelter will not be held responsible.

In the event your place is affected by any such changes, the event organiser Cheltenham Animal Shelter will contact you about your place.

Fundraising

Data protection
